**SUMMARY & BACKGROUND** 

On March 11, 2021, the President signed into law the American Rescue Plan Act of 2021 (ARP). ARP makes available \$122.8 billion nationally in a third round of Elementary and Secondary School Emergency Relief (ESSER) funds. New York State has been allocated nearly \$9 billion under the ARP Act's Elementary and Secondary School Emergency Relief (ESSER) Fund. The ARP Act requires that a minimum of \$8.09 billion (90 percent) be allocated to LEAs, including charter schools and Special Act School Districts that are LEAs. Pursuant to the terms of the ARP Act, LEA allocations have been calculated using the relative shares of grants awarded under Title I, Part A of the ESEA for the most recent federal

fiscal year (2020). Each eligible LEA's ARP-ESSER allocation may be found HERE.

Under section 2001(d)(2) of ARP Act of 2021, each State Educational Agency (SEA) must make ARP-ESSER allocations to LEAs in an expedited and timely manner and, to the extent practicable, not later than 60 days after the SEA receives its ARP-ESSER funds. • ARP-ESSER Application – Part 2: The second step will be the submission of a full application and budget by the LEA. NYSED will issue a Grant Award Notice (GAN) to the LEA after the LEA's application is fully reviewed and approved by NYSED. Part 2 will address several of the

plan-related assurances an LEA must provide in Part 1 of the application process.

The ARP Act requires LEAs to reserve at least 20% of their 90% ARP-ESSER allocation to address learning loss through the implementation of evidence-based interventions, such as summer learning or summer enrichment, extended day, comprehensive afterschool programs, or extended school year programs, and ensure that such interventions respond to students' academic, social, and emotional needs and address the disproportionate impact of the coronavirus on economically disadvantaged students, children with disabilities, English learners, racial and ethnic minorities, migrant students, students experiencing homelessness, and children and youth in foster care. To develop a plan for our ARP funds, we engaged a diverse set of stakeholders that represent the students we will serve with these funds. We accomplished this by providing a survey seeking the input of our stakeholders, including families, staff and faculty, and school leadership, on the use of our funds. The survey included an opportunity for respondents to express their priorities for supporting students as they return to school after COVID-19. The survey was sent to our community in November 2021, including parents and staff. We used the results of this survey to design our plan for spending ARP funds. As we implement the spending plan, we will continue to engage stakeholders by conducting another survey in 6 months.

We use these data sources to assess progress and inform our school program for all students, including students with disabilities, English language learners, economically disadvantaged subgroups, and other at-risk populations. We use the following strategies to provide academic and social-emotional interventions for struggling students:

Academic interventionists are broken up by grade level. They meet with each grade two times per week. They offer small group support (push-in and pull out) depending on the class needs. They plan with the teachers and use timely data to determine which supports are most needed for students. We have also implemented an extended day program for our scholars who have demonstrated that they are performing far below grade level expectations. We have embedded SEL lessons that every grade participates in once per week. Quaver curriculum is being used by our team and it includes: video, lessons, songs, and materials to support student learning. The guidance counselor and behavior specialist are leading this work for our team. We have also SEL visual anchors posted in every classroom and hallways and student reference them during lessons, morning meeting, and during peace talks. We have also incorporated adult/student check-ins daily to help gauge any supports students may need - there are several adults who check-in with students as they arrive and throughout the day.

We are allocating our ARP grant to salaries for instructional staff who are dedicated to addressing learning loss.

Learning Loss teachers - Our interventionists work closely with our instructional staff to plan and to implement targeted supports to students who need additional supports to meet grade level expectations.

Our Learning Loss educators lead research-based teaching practices to small groups. They use data to reteach areas of unfinished learning for struggling students. They focus on helping students to master foundational ELA and math skills that they may have missed in previous years. They co-plan with teachers and use the core curriculum to differentiate content for their small groups.

Social Emotional Learning Loss Counselors - In addition to our school-based guidance counselor who leads small groups, meets with mandated groups, and supports our SEL curriculum we have also added a guidance counselor intern who will provide additional bandwidth to our student population.

Our staff members are committed to supporting all students, including our disadvantaged population, with the transition back to inperson learning. Nearly all of our school's students are from either economic disadvantage, ELL, disabilities, or a combination of more than one. Please see above for a description of how the funds will be used to support our students, including economically disadvantaged students, students with disabilities, English language learners, and other student populations.

Our school has a significant population of students with disabilities - and these students have struggled the most since the pandemic began - mainly due to lack of hands on and manipulative learning replaced by online learning for 18 months. Students with disabilities - and to a similar extent - English Language Learners, will experience the benefit of being back in live instruction with significant in-person supports and small grouping made possible by not only the ARP grant, but also the pervious CRRSA grant.
